Subject: <u>Gran Premio Nuvolari 2021 – clarifications and updates regarding the Covid-19 regulations in force referring to sporting events</u>

Seen:

- The Decree of the President of the Council of Ministers of 2nd March 2021 containing "Further implementing provisions" of the decree-law of 25th March 2020, n. 19, converted, with amendments, by law 22nd May 2020, n. 35, containing "Urgent measures to deal with the epidemiological emergency from COVID-19"
- The decree-law of 16th May 2020, n. 33, converted, with amendments, by law 14th July 2020, n. 74, containing "Further urgent measures to deal with the epidemiological emergency from COVID-19"
- The decree-law of 23rd February 2021, n. 15, containing "Further urgent provisions regarding travel on the national territory for the containment of the epidemiological emergency from COVID-19"
- The decree-law of 22^{nd} April 2021, n. 52 containing "Urgent measures for the gradual resumption of economic and social activities in compliance with the need to contain the spread of the COVID-19 epidemic", converted with amendments by law 17^{th} June 2021, n. 87
- The decree-law of 23rd July 2021, n. 105 on "Urgent measures to deal with the epidemiological emergency from COVID-19 and for the safe exercise of social and economic activities"

It is attested that:

in order to allow the regular performance of sports competitions recognized as of pre-eminent national interest by CONI*, the entry into Italy of athletes, technicians, journalists of the foreign press, judges, race commissioners, and accompanying people from other countries (also from whom entry into Italy is prohibited or for which quarantine is prescribed) is permitted.

Provided that:

they are in possession of the **EU Digital COVID Certificate** [further details at the link: https://ec.europa.eu/info/live-work-travel-eu/coronavirus-response/safe-covid-19-vaccines-europeans/eu-digital-covid-certificate_en], and that they have filled out the **European digital Passenger Locator Form (dPLF)** [further details at the link: https://euplf.eu/en/home/index.html].

After the closing of the registrations, the Organizer Mantova Corse will communicate to the competitors the acceptance to the Gran Premio Nuvolari 2021 and will send them an Official Notification of Participation, which will serve to the drivers as a certificate of admission in Italy, as they are taking part in a competitive sporting event recognized of pre-eminent national interest by CONI and ACI Sport.
